FROM THE EDITOR

Looking to the future-

As Wall Street acclimatizes itself to higher interest rates, the U.S. economy's hopes that the Omicron variant will loosen the pandemic's stubborn grip. Shipping people are faced with the longer-term effects on future freight rates, whether to build ships, sell ships, or sell and lease back. As Ground Hog Day 2022 passes I ask if we have been here before. Is this "déjà vu" all over again"? Perhaps, but I suspect future cycles will be shorter than we have seen before. Why? Globalization 4.0 onward.

Twenty-five years ago, the word sustainability entered our conversations. At that time in shipping "sustainability" only encompassed economics. OPA 90 FORUM

A special webinar presentation -February 11, 2022

Can a ship be hacked? Can a vessel's navigation systems or propulsion be the victims of a cyberattack? Can a pipeline, refinery, or offshore platform Operational Technology (OT) environment be attacked with intent to cause an environmental release or create a safety hazard for the people living or working in proximity? Has this already happened? Most are aware of the very real risk and capability for an attack on the IT enterprise systems of a company. Our panel of experts will raise awareness as to the risk to the environment and the very real possibility of a cyberattack impacting OT systems to cause an oil spill.

When OPA 90 was first enacted, Congress, industry and regulatory agencies envisioned the impetus for an oil spill to come from mechanical failure, human error, or natural disaster, not



the deliberate hack of an OT or Industrial Control System (ICS). But, in today's world, this is a very real risk, depending upon the level of prevention, preparedness and response capability the operator has invested into their systems.

The OPA 90 Forum invites you to join a panel of experts as we explore the real possibility of an oil spill caused by a cyberattack. Such a possibility was not envisioned at the enactment of OPA 90. The Forum is hosting this event to raise awareness of these risks and the importance of their mitigation.

Admiral Thad Allen, 23rd Commandant of the US Coast Guard, will offer opening remarks and moderate this 90minute discussion. Admiral Allen will be joined by the following individuals.

Rear Admiral John Mauger, Assistant Commandant for Prevention Policy, US Coast Guard - RADM Mauger is responsible for the development of national policy, standards, and programs promoting Marine Safety, Security and Environmental Stewardship. Three Directorates carry out the mission: Inspections and Compliance, Marine Transportation Systems, and Commercial Regulations and Standards. Programs include waterways management, navigation and boating safety, ports and facilities, merchant mariner credentialing, vessel documentation, marine casualty investigation, commercial vessel inspections, and port state control.

His prior flag assignments include the Assistant Commandant for Capability, and the Director of Training and Exercises (J7) at U.S. Cyber Command.

Mr. Kyle Miller, Principal/Director, Booz Allen Hamilton Operational Technology (OT) Cybersecurity Practice for Global Commercial.

As a Principal/Director at Booz Allen Hamilton, Mr. Miller oversees the firm's Operational Technology (OT) Cybersecurity practice within the Global Commercial account. He acts as an ICS/SCADA cybersecurity SME to a myriad of clients, serves as technical director for internal ICS investment efforts, as well as leads client delivery across a number of market areas.

With over fifteen years of professional experience, Mr. Miller has worked with a multitude of clients across the manufacturing, oil & gas, defense, energy, and water/wastewater critical infrastructure sectors. These clients have included Fortune 100 and Global 2000 organizations as well as the United States Department of Defense (DoD) and other Civil agencies. Throughout this time, he has conducted security design engineering efforts, architected secure control system networks, and built-out control system focused threat detection and response programs. He has also developed service-wide and company-wide risk assessment frameworks and conducted on-site security reviews at hundreds of plants/facilities. Mr. Miller holds various professional certifications including: GICSP, CISSP, CEH, CHFI, ISO 27001 Lead Auditor, Security+, and PMP; as well as two Graduate Certificates and a Master's Degree in Cybersecurity.

Mr. Zachary Tudor, Associate Laboratory Director, National and Homeland Security, Idaho National Laboratory's National and Homeland Security Science and Technology Directorate.

At INL, Mr. Tudor is responsible for INL's Nuclear Nonproliferation, Critical Infrastructure protection and Defense Systems missions. Previously, he served as a Program Director in the Computer Science Laboratory at SRI International, where he supported cyber security and critical infrastructure programs such as DHS Cyber Security Division's Linking the Oil and Gas Industry to Improve Cybersecurity (LOGIIC) consortium and the Industrial Control System Joint Working Group R & D working group.

Mr. Tudor is a retired US Navy Submarine Electronics Limited Duty Officer and Chief Data Systems Technician. He holds an MS in Information Systems from George Mason University concentrating in cybersecurity, where he was also an adjunct professor teaching graduate course in information security.


